We hope that we never have to use it, but in case of an emergency, it is important that we have the accurate information. So, please take the time in filling this form out completely. Any of the fields that are highlighted in **RED** are **REQUIRED**. Any that are in **BLUE** are **OPTIONAL**.

A separate form is needed for each camper. However, if a camper is going multiple sessions, only one form is needed.

If something does happen, please call us (phone numbers will be provided). If you are late picking up your child, more than once, we will have to enforce **late penalties** (\$1/minute after 15 minutes - per child). If you know you will not be there on time on a regular basis, you can choose the option of having your camper left unattended at the end of the day.
